AP GOVERNMENT AND POLITICS

SYLLABUS (2015-2016)

COURSE OVERVIEW/DESCRIPTION

This course explores the political theory and everyday practice that direct the daily operation of our government and shape our public policies. The express purpose of this course is to prepare students to take the AP U.S. Government and Politics Exam. The course is for all intents and purposes taught on a college level, and it requires a substantial amount of reading and preparation for every class.

The objectives of this course go beyond a basic analysis of how our government "works." Students will develop a critical understanding of the strengths and weaknesses of the American political system, as well as their rights and responsibilities as citizens.

This syllabus is not designed to show all that we do in class. Instead, it is an overall guide that will help the students to see where we are starting and where we are going. It will allow them to pace themselves throughout the year. It will also give them a sense of accomplishment as they can highlight the assignments that they have accomplished as the year progresses.

The class is divided into four quarters. In the first quarter we will focus on constitutional foundations. During the second quarter will focus on people and politics. In the third quarter we will focus on the policymakers. During the fourth quarter we will focus on policies. Each quarter is made up of the following things: First, teachings on American government taught through various methods of instruction and based on the book *Government In America*. Second, free-response questions gathered from old AP American government exams and the internet. The students will work with the FRQ's as homework, class discussion, debate, and on tests. On the tests I will give the students three FRQ's of which they will have to pick one. Third, primary source readings from the book *American Government: Readings and Cases*. The students will read and be prepared to discuss and be tested on the reading material. Fourth, the students will be given homework's that will be an assortment of multiple choice questions, maps, graphs, pictures, and drawings. The students will have to analyze the evidence and give their interpretations in their answers. Lastly, a large multiple choice test will be given at the end of each chapter to gage the students comprehension of the material.

GRADING AND COURSE REQUIREMENTS

Grades are figured on a cumulative point basis. Each test, quiz, homework assignment, etc., is worth a given number of points according to the quality and level of completed work. At the end of a marking period, a grade average is determined by dividing the total points possible by points earned.
